If there are any discrepancy and non-declaration of results in the result sheet, the Principal/Chairman are requested to bring it to the notice of the Registrar (Evaluation) within 15 days from the date of announcement of results failing which no further requests on the same will be entertained.

Revaluation Application Procedures:

1. (a) After declaration of results, if any candidate wishes to apply for may do so within the dates as mentioned below by visiting Bangalore University website www.bangaloreuniversity.ac.in (b) Then click online payment, link buofc.inhawk.com (c) Then select Revaluation menu and enter the correct Register No. The Name, College Name, Course Name, Semester will be displayed automatically. (d) Then student has to select option i.e Revaluation. (e) Then the paper code details will be displayed. Student has to select the number of papers for Revaluation. (f) Then click calculate option then click make payment option. (g) Now students can pay by Credit/Debit card and Net banking. (h) After successful payment receipt will be generated. (i) After generating the receipt, students will get SMS and email for the receipt details.
2. There is no challenge valuation for P.G. Courses.
3. There is no provision for Revaluation of Open Elective Subject (only Theory papers)
4. Fees once paid either for Revaluation will not be refunded or adjusted for future Examinations.

FEE STRUCTURE FOR REVALUATION FOR PG COURSES:

1. Application fee for Revaluation	-	Rs. 60/-
2. Revaluation fees	-	Rs. 1,320/- per Theory Paper
3. Last date to apply for Revaluation within 15 days from the date of announcement of Results.	-	11.09.2019
4. Last date with fine of Rs.250/-	-	18.09.2019

No application for revaluation will be entertained after the last date.
