After announcement of results, a candidate applying for revaluation may do so within the dates as mentioned below by visiting Bangalore University website: [www.bangaloreuniversity.karnataka.gov.in](http://www.bangaloreuniversity.karnataka.gov.in) click Online payment link [buofc.inhawk.com](http://buofc.inhawk.com), then select Revaluation menu and enter the correct Register No, Name, College Name, Course Name, Semester which will be displayed automatically. Then select option i.e. Revaluation, then the paper code details will be displayed, then select the number of papers for Revaluation, & click Calculate option & finally click Make Payment option. The payment can be made by Credit/Debit card and Net banking. After successful payment receipt will be generated. After generating the receipt, students will get SMS and email for the receipt details.
2. There is no challenge valuation for P.G. Courses.
3. Candidates who have secured 15% of maximum marks or more in each paper are eligible to apply for Re-Valuation, by paying the prescribed fees notified by the University from time to time.
