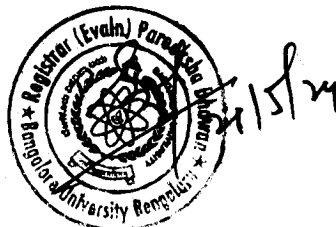

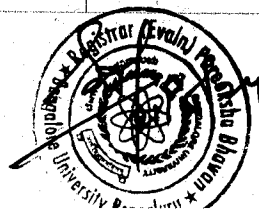

Those Students have to submit the Post-Matric Scholarship application through online in the State Scholarship Portal (SSP), Govt of Karnataka.

BU Departments/Principals of the Affiliated Colleges shall instruct the eligible SC/ST students of Karnataka to submit their online Post- Metric Scholarship application (on which the photo of the students and 12 digit UUCMS Registration number is displayed) in the SSP without fail.

The students who do not fulfill the attendance requirement shall not be permitted to take the Examination at any circumstances and the application of those students shall not be entertained.

Note:- The Chairperson of the University Departments/ Principals of the Affiliated Colleges are directed to submit the above documents along with Financial Statement, Fee paid Receipts to the PG Preparatory Section.

The Chairpersons of BU Departments / Principals of Colleges shall ensure that the students whose admissions are not approved by the University/having shortage of attendance, such candidates shall not be allowed to appear for the Examination.

As per rules, a student has to satisfy a minimum 75% of attendance in each subject out of 90 working days in each semester to become eligible to appear for the Examination.

Students who satisfy the above 75% attendance requirement, during the current semester shall be allowed to appear for the ensuing Examination. Those students, who do not satisfy the above mandate, shall not be issued Hall Tickets by the Chairpersons of the Departments / Principals of the concerned Colleges.

Payment of Examination fee and submission of application for the Examination alone do not entitle a student to take the Examination, if he/she is not eligible as per Rules / Regulations governing the eligibility, viz., Approval of Admissions / Shortage of Attendance etc.

The Examination fee once paid will not be refunded or re-adjusted under any circumstances. The Internal Assessment Marks secured by the candidates shall be displayed at least one week prior to the last working day of each semester on the Notice Board.

The statement of Internal Assessment marks shall be sent to Registrar (Evaluation), one week before the commencement of theory Examinations of that particular semester without fail.

The candidate shall take the examination as per the syllabus and the Scheme of Examination in force during the subsequent appearances.

As per the Guidelines of UGC on determination of a Uniform Span Period within which a student may be allowed to qualify for a degree, it is as below:

Time Span = N+2 Years for the completion of Programme.

Where N stands for the normal or minimum duration prescribed for completion of the Programme.

A candidate should complete the Master's degree examination within 4 (four) academic years from the date of his/her admission.

The Practical Examinations for the course wherever prescribed will be notified by the Chairperson/Principal of the concerned Departments / Colleges.

The Heads of the Institutions are requested to send the financial statement including repeaters semester wise separately in THREE SETS of the respective Examination and Subject-wise statement in Triplicate along with ONLINE Receipts on or before 05.06.2024.

Question paper requirement along with one set of Subject-wise statement shall be submitted to the Confidential Section directly on or before 05.06.2024. Failing which, penal fee of Rs.5000/- will be levied for late submission.
