It is hereby notified that, the procedures to be followed for collection of examination fees of II & IV semester (Freshers & Repeaters) BA/BSc/B.Com/BBA/BBM/BCA/BSW/ B.Voc (IT)/ B.Voc (MLT)/ B.Voc (RM)/ B.Voc(FP&N)/ B.Sc(H.Sc)/ B.Com(HONS)/ B.Sc(IDD)/ B.Sc (Forensic Science) and BASLP/BVA/BHM II, IV & VI Semester etc., (Freshers & Repeaters) examination of **September/October 2021** and filling of examination application forms are as detailed below. The Officers/Officials of Examination Section of BU and Principals and their staff of affiliated colleges have to follow the procedures laid down scrupulously as was done during previous examinations.

Further, as per the resolution of the Syndicate dated: 04.02.2015, in addition to the Examination fee the candidates who are appearing for Final Semester Examination as fresher & also repeaters have to pay prescribed degree certificate fee also.

1. The Principals of the Concerned College are request to Entry the **examination application forms** from Online portal of Bangalore University, the candidates are request to pay the required examination fees Online, submit the same to their respective college Principals on the same day of payment of examination fees. The candidates may also make a photo copy of the duly filled application forms and obtain an acknowledgement on the photocopy from their respective Principals for having submitted the application to the college. This photocopy should be produced to the University for any Clarification. No examination application form will be accepted after the due date under any circumstances.
2. The candidates are required to pay the following prescribed examination fees as per the list enclosed. Fees to be paid by **"ONLINE PAYMENT"** for more information visit www.bangaloreuniversity.ac.in.

Note (a)*: A Scrutiny Fee of Rs. 11/- to be collected from each student. Out of this, college should retain Rs. 9/- and Rs. 2/- be credited to the University Fund. The retain amount of Rs. 9/- by the college shall be utilized towards contingency expenditure including stationery and all other incidental expenses (except answer books postages)

Note (b): College offering Courses Having practical/Viva-Voce/Project/Dissertation Examination shall contact the respective BOE Chairpersons well in advance for conduct of the said examination.

1. Information Regarding Scholarship(FEE CONCESSION FROM THE GOVT):

- The Principals of the colleges are not supposed to demand the prescribed examination fees from SC/ST students of Karnataka (ಸರ್ಕಾರದ ಆದೇಶ ಸಂಖ್ಯೆ: ಸಕಾಇ-83/ಪ.ಕಾಬಿ. 2012, ಬೆಂಗಳೂರು ದಿನಾಂಕ: 27.06.2013). The fees prescribed to be paid by them will be reimbursed by the Social Welfare Department on Submission of On-line Post Metric applications by the SC/ST students.



The Principals should ascertain that the SC/ST student have submitted the following photocopies of the documents (attested by the Gazetted Officer) along with on-line Post-Metric Application (on which the photo of the student and 15 digit Registration Number is displayed):-

1. Caste Certificate of the student issued by the Tahsildar.
2. Parents Annual Income Certificate (less than or equal to Rs.2.5 lakhs) issued by the Tahsildar. (Valid up to 5years) (If the parent of the student is a state/Central Government Employee, Salary slip shall be insisted along with the income Certificate).
3. Previous year Marks card / Result sheet.

However the SC/ST Students whose fees are reimbursed form the social welfare Department shall pay only the OMR sheet fee of Rs.17/- each for Theory Practical and Viva-Voce/Project/Dissertation.

The Principals of the colleges shall obtain the reimbursement of fees by forwarding the online post-metric applications to the social welfare Department. The fees will be remitted to principal's account DIRECTLY by cash Transfer from the social welfare department. **If the fee so remitted to principal's account is disbursed to the concerned students, the concerned principal shall collect the prescribed fees of this semester along with the fees of previous semester form such SC/ST students and remit the same to the University account without fail.**

- b. **THE FOLLOWING SC/ST CANDIDATES ARE NOT ELIGIBLE TO CLAIM FEE REIMBURSEMENT**
 1. SC/ST student from other states.
 2. SC/ST students of Karnataka whose parent's annual income is more than 2.5lakhs.
- c. However, if the above documents are not found to be enclosed along with the online post-metric application, the principals shall collect the full prescribed fee from the SC/ST students. The fee reimbursement is not applicable for repeaters who belong to SC/ST of Karnataka. Hence, the principals shall collect the prescribed fees from the repeaters and SC/ST students of other states and remit the same to the University account.
- d. In case of non-receipt of Scholarship/Fee reimbursement of a particular student from the Social Welfare Department for the reasons mentioned there in by the Social Welfare Department, the Principal shall collect the prescribed fee of this semester along with fee of previous semester and remit the same to the University account without fail.
- e. As per Govt. Order. No. ಹಿಬಿಸಿಜೆ/589/ಬಿಎಂಎಸ್/2013, ದಿನಾಂಕ 5-10-2013 ಮತ್ತು 06-08-2014, The Tuition, Laboratory, Examination, Library and Sports fee (The amount of Fees prescribed by the University or the maximum limit of fees fixed by the BCWD WHICHEVER IS LESS) OF THE Cat-1, 2A, 3A & 3B and other students will be reimbursed to the concerned College Bank Account, for the students who are eligible for admission to the said course and year, subject to the condition that the Annual Income limit which is reflected in the Government Order (Cat-1 students whose Parent's Annual Income is less than or equal to Rs. 2.5 lakhs and other 2A, 3A & 3B students whose Parents' Annual Income is less than or equal to Rs. 1.0 lakhs are eligible to apply for the reimbursement of fees).



- f. The candidates belonging to **minorities** (i.e, Muslims, Christians, Buddhists, Sikhs, Anglo Indians, Jains etc.,) whose parent's annual Income is less than or equal to Rs. 2,00,000/- (Rupees Two Lakhs only) are eligible to apply for incentive of Rs. 4,000/- from **Minorities Welfare Department (MWD)** as per the norms of MWD (ಸರ್ಕಾರದವರೇ ಸಂಖ್ಯೆ: MWD 21/MDS2011 dated 02-08-2014).
- g. **The principals of the Colleges shall collect the prescribed examination fees from the Cat-1, 2A, 2B, 3A, 3B and other students. The prescribed fee shall also be collected from SC/ST students whose parents' annual Income is more than are 2.5 lakhs.**
- h. The Principals of the Colleges should give undertaking to the effect that they would get the re-imbursement of Examination fees of students and remit them to the University.
2. **The mere payment of examination fee and submission of applications does not entail the student to appear for the examination, unless he/she fulfils all the conditions of the course laid down in the regulation of the course by the University.**
3. The Practical examinations time-table for the course wherever prescribed will be notified by the Chief-Superintendent of the concerned examination center. The practical examination should be conducted before theory examination. After the completion of all the practical examinations, the practical OMR sheets should be inserted in colored covers, semester wise, course wise, subject/paper wise and seal the same. Sealed Practical OMR sheets covers should be submitted to the office of the Registrar (Evaluation), Prareeksha Bhavana, Jnana Bharathi, Bangalore 560056 on or **before** detailed Time Table for Theory Examination will be notified in due course.
4. Colleges have to collect the practical OMR sheets duly printed with Reg. No. and the coloured covers from the Office of the Registrar (Evaluation), Prareeksha Bhavana, Jnana Bharathi, Bangalore – 560 056, on or **before**.
5. **The Internal Assessment/Grading (as applicable) shall be submitted through on line on or before to the University website www.bangaloreuniversity.ac.in Using the same Pass Word given previous year, and also hard copy of the Internal Assessment /Grading (as applicable) should also be submitted on or before to the Registrar (Evaluation) Pareeksha Bhavana, Jnana Bharathi, Bangalore-560056. IA received after the last date will not be accepted. Therefore, he Principals are requested to pay their personal attention and ensure that IA marks/ grades are correctly submitted before the last date positively to avoid any inconvenience to the students. The Principal of the respective college will be personally held responsible for non-submission of IA marks/Grades. Failure on the part of the Principal in this regard will be viewed seriously and the matter will be reported to the commissioner, Higher Education and the Principal Secretary, Higher Education for further action.**
6. Late submission of examination applications consolidated Financial statement and candidate list to the university by the colleges will attract penal fee for Rs, 5,000/-



7. Question paper Indent Pro-forma will be hosted on University web site www.bangaloreuniversity.ac.in during the Second week of **06.09.2021** the same should be downloaded and fill the same. Filled question paper indent (Hard Copy only) along with one set of candidate list (for verification & return) should be submitted to the Confidential Section, Examination Branch, Natural Science Block, Central College Premises, Dr. Ambedkar Veedhi, Bangalore -560001 on before **06.09.2021** Failing which Rs. 5,000/- will be imposed as penal fee for late submission.
8. As per regulation governing UG courses, a candidate should complete his/her degree course within Five Academic Years from the date of admission to the First Semester. (ACA/UGC-Guidelines/Span Period/17-18 dated 13.07.2017 Circular).
9. As per resolution of the Academic Council meeting held on 03.09.2020 the Semesters/CBCS students who have registered for admission from 2004-2005 and onwards and who have completed the course but have failed in subjects are permitted to take II & IV Semester (II, IV Semester BHM) examinations of SEPTEMBER/OCTOBER-2021 under one time measure. However, they have to study and pass the examinations/subjects as per the existing syllabus of their respective scheme only.
