- 1) SC/ST Category students who are receiving Post metric scholarship are required to pay the prescribed fee as the social welfare Department are transferring the scholarship amount (including Exam fee, Marks Card etc) to their Bank Account directly. Hence they are required to pay the Examination of fee Rs. 2090=00(Rs. 1842+Rs 248).
- 2) Fee Concession is not applicable for repeaters who belong to SC/ST Category of Karnataka / other state.
- 3) II/ IV Sem Students belonging to SC/ST Category, who have availed Examination fee concession for I/III Sem B.Tech/B.Arch Exam April/May 2021 are required to pay Rs. 2,090=00(Rs. 1842 + R.s 248) thro Online separately mentioning as "Exam Fee April/May 2021" as the post metric scholarship amount is being transferred by Social welfare Department to the students Bank Account, failing which exams. Marks Card will not be issued by the Department.
- 4) IVth Sem B-Tech/B.Arch Students (2019-2020 Batch) belonging to SC/ST Category, are also required to pay I Sem B.Tech/B.Arch September-2020 Examination fee of Rs. 2,090=00 & also IInd Semester B.Tech/B.Arch Feb-2021 Exam fee of Rs. 2,090=00, thro Online as the Scholarship amount (including Examination fee) were transferred to student's Bank Account by Social welfare Department (As per circular Dated: 05-01-2021 & 28-07-2021 of Principal, UVCE), failing which Exams Marks Card will not be issued by the Department.
- 5) The fee concession is not applicable for repeaters who belong to SC/ST/Cat-1, 2A, 3A, 3B and other students of Karnataka and SC/ST students of other states. Hence, the Principal/Chairman shall collect the prescribed fees from the repeaters and SC/ST students of other states.

The Principal / Chairpersons of Departments of UVCE, Bangalore University shall ensure that the students whose admissions are not approved by the University/having shortage of attendance such candidates shall not be allowed to appear for the Examination.

Students who satisfy the 75% attendance requirement during the current Semester are allowed to appear for the ensuing Examination. Those students, who do not satisfy the above mandate, shall not be issued Hall Tickets by the Chairpersons of the Departments / Principals of UVCE.

Payment of Examination fee and submission of application for the Examination alone do not entitle a student to take the Examination, if he/she is not eligible as per Rules / Regulations governing the eligibility, viz., Approval of Admissions / Shortage of Attendance etc.

The Examination fee once paid will not be refunded or re-adjusted under any circumstances. The Internal Assessment Marks secured by the candidates shall be displayed at least one week prior to the last working day of each semester on the Notice Board. The statement of Internal Assessment marks shall be sent to Registrar (Evaluation). B'lore Univ., B'lore, one week before the commencement of theory Examinations of that particular semester without fail.

The Practical Examinations for the course wherever prescribed will be notified by the Chief Superintendents of the concerned Departments before commencement of Theory & Practical Examination .

Students shall submit a copy of examination fee receipt to the chairman/chairperson of the department.

Question paper requirement along with one set of candidates' list shall be submitted to the Confidential Section directly on or before 13-12-2021. Examination, failing which, penal fee of Rs.5,000/- will be levied for late submission.
