Revaluation Application Procedures:

- 1. After Announcement of results, if any candidate wishes to apply for revaluation may do so within <u>the dates as mentioned</u> below by visiting Bangalore University website: <u>www.bangaloreuniversity.ac.in</u>. They have to click online payment link <u>buofc.inhawk.com</u>. Then select Revaluation menu and enter the correct Register No. The Name, College Name, Course Name, Semester which will be displayed automatically, then student has to select option i.e Revaluation, then the paper code details will be displayed, student has to select the number of papers for Revaluation, then click calculate option then click to make payment option. Now students can pay by Credit/Debit card and Net banking. After successful payment receipt will be generated. After generating the receipt, students will get SMS and email for the receipt details.
- 2. The Candidates can download their photocopy of answer script by entering the Register Number by visiting website: <u>www.bangaloreuniversity.ac.in</u> from the dates mentioned below photocopy will not be sent to the e-mail address of the candidates or dispatched by post.
- 3. The photocopy will not be hosted for candidates applying for Revaluation after the last date prescribed for photocopy.
- 4. There is no challenge valuation for U.G. Courses.
- 5. The photocopy can be downloaded by the students who have not taken the exam under one time measure.

- There is no provision either for photocopy or Revaluation for Non-6. Core subjects.
- Fees once paid for Revaluation will not be refunded or adjusted for 7. Future Examinations.
- The photocopy will be issued to the students who have taken 8. examination under one time measure and applied for photocopy from 25.10.2022 onwards in the LL.B Marks Cards Section, 2nd floor, Pareeksha Bhavana, Jnanabharathi Campus, Bangalore University, Bengaluru -56, during the office hours.
