**ADMISSION NOTIFICATION**

**Preamble :** In view of an enactment of a legislation by the Government of Karnataka during 2020, which restricts admission of students for admission through distance education at the Directorate of Distance Education/Correspondence Courses, in the erstwhile Universities in the State of Karnataka and exclusively permits only the Karnataka State Open University at Mysore, to run the Distance Education Programme from the academic year 2020-21. As such, for such of those students who had taken admission at the Directorate of Distance Education, Bangalore University, Bangalore, during the academic year 2019-20, the admission for the II and III year of UG and II year PG courses should only be made for the academic year 2020-21. Hence this notification.

As such, applications are invited for admission to various courses of UG (Under Graduate II and III year Courses), PG (Post Graduate II year Courses), in Correspondence Scheme under the Distance Education mode for the academic year **2020-21**.
