The candidates are advised to fill in all the relevant columns in the Examination application form correctly, failing which the applications are liable to be rejected and they are also advised to preserve the acknowledgement portion of the application forms. Particulars of the previous attempt, subjects passed with Register numbers and year of passing and subject/s should invariably be entered in the application and copies of marks cards must be enclosed. Examination application forms should be submitted to the Directorate of Correspondence Course, BUB by the students on the last date stipulated for payment of Examination Fee through Online. The detailed Time-Table for the Theory Examinations will be notified in due course. **The Practical Examinations may be conducted before the Theory Examinations and submitted Practical Marks List before the commencement of Theory Examinations.**

The Directorate of Correspondence Courses and Distance Education is requested to record a Certificate at the end of each candidates list as follows:

"The Name of the Candidates included in the lists have been approved by the University and only the Candidates who are eligible to take the Examinations as per the University Regulations are included in the list".

The Directorate of Correspondence Courses and Distance Education is requested to send the applications along with prescribed perform so as to reach BA / B.Com / BBM Preparatory sections concerned on or before **30.09.2024** by MUDDAM, **failing which Rs. 5,000/- will be imposed as penalty for late submission.**

The Directorate of Correspondence Courses and Distance Education is requested to collect the Examination Fee from the students and remit the same to the University Funds by **ONLINE PAYMENT** on or before **24.09.2024 (WITHOUT FINE) & 30.09.2024 (WITH FINE)** as the case may be and the fee collection statement has to be sent by the Directorate of Correspondence Courses and Distance Education together with the applications duly scrutinized. It is the responsibility of the Directorate of Correspondence Courses and Distance Education to ensure that Examination Fees prescribed is collected and remitted to Bangalore University Funds promptly. The financial statement in



quadruplicate with necessary certificates thereon may be sent directly to the Finance Officer, Bangalore University, Bangalore, with a copy to the Registrar (Eva).

3. Question paper requirement along with one set of candidate list should be submitted directly to the Confidential Section on or before **01.10.2024**
4. Financial Statement of Examination fees in triplicate.
5. List of candidates appearing simultaneously for more than one examination in triplicate
6. Students' appearance combination-wise to be given in the enclosed proforma.

Question paper indent along with one set of candidate list should be submitted directly to Confidential Section, Pareeksha Bhavana, Jnanabharathi Campus, Bengaluru-56. on or before **01.10.2024** failing which Rs. 5,000/- (Rupees Five Thousand only) will be imposed as penalty for late submission.
