After declaration of results, if any candidate wishes to apply for Revaluation may do so within the dates as mentioned below by visiting Bangalore University website www.bangaloreuniversity.karnataka.gov.in (a) Then click online payment, link buofc.inhawk.com (b) Then select Revaluation menu and enter the correct Register No. The Name, College Name, Course Name, Semester will be displayed automatically. (c) Then student has to select option i.e Revaluation. (d) Then the paper code details will be displayed. Student has to select the number of papers for Revaluation. (e) Then click calculate option then click make payment option. (f) Now students can pay by Credit/Debit card and Net banking. (g) After successful payment receipt will be generated. (h) After generating the receipt, students will get SMS and email for the receipt details.
2. The Candidates can download their photocopy of answer script by entering the Register Number by visiting website: www.bangaloreuniversity.karnataka.gov.in from the dates mentioned below photocopy will not be sent to the e-mail address of the candidates or dispatched by post.
3. The Candidates who have secured 15% of maximum marks or more in each paper are eligible to apply for Re - Valuation by paying prescribed fee.
4. The photocopy will not be hosted for candidates applying for Revaluation after the last date prescribed for photocopy.
5. The photocopy shall be downloaded within one month from the date of hosting Thereafter; it will not be available on the website.

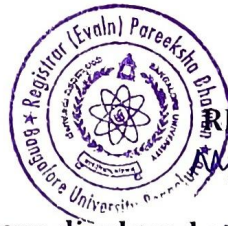
