(d) Then student has to select option i.e Revaluation. (e) Then the paper code details will be displayed. Student has to select the number of papers for Revaluation. (f) Then click calculate option then click make payment option. (g) Now students can pay by Credit/Debit card and Net banking. (h) After successful payment receipt will be generated. (i) After generating the receipt, students will get SMS and email for the receipt details.
2. The Candidates can download their photocopy of answer scripts by entering the Register Number by visiting Website: www.bangaloreuniversity.karnataka.gov.in From the dates mentioned below. Photocopy will not be sent to the e-mail address of the candidates or dispatched by post.
